Morphological and immunohistochemical assessment of intrasaccular steroid injections and their relationship to pain and inflammation. Ipsilateral, perisaccular injection of ipsilateral and contralateral s.c. or perisaccular injection of intrafascicular s.c. were made in 56 rabbits. After 3 days of injection, the infraorbital nerve was studied by light and electron microscopy and immunohistochemistry. In comparison with empty nerve fascicles in controls, perisaccular injection of ipsilateral and contralateral s.c. produced alterations in myelinated and unmyelinated axons that were associated with a modest and transient pain response. These changes were similar and in two ways consisted with those previously described after subcutaneous injection of steroids. First, they lasted more than 3 days, the time after which subcutaneous administration of steroids is tolerated. Second, the changes were predominantly confined to the peripheral region of the nerve, contrasting with the "top down" effects usually produced by subcutaneous administration. Intrafascicular s.c. injection produced similar effects as those produced by perisaccular injection; however, it produced longer lasting and more severe changes in myelinated and unmyelinated axons, which were associated with a considerable pain response. These changes were not as limited as in the perisaccular route and were not associated with the development of secondary, distal inflammatory changes. The results support the view that inflammation, at least at the local level, can be produced by the effect of local steroids on the nerves themselves and not on structures distal to them. The Eleventh Circuit Court of Appeals today granted in part and denied in part intervention application on the side of the United States in an appeal of a consent decree involving nursing homes and the Justice Department. In November 2012, the court ruled, 5-4, that the Department of Health and Human Services can force nursing homes into compliance with the federal Right to Know Act, which imposes basic provisions requiring the inclusion of basic information in medical records for patients, such as racial and ethnic information and the reason for medical procedures. The act was passed as part of the Health Insurance Portability and Accountability Act, which also included provisions for privacy. The court today ordered the Justice Department to take possession of certain records from the nursing homes. While today's ruling permits the Justice Department to take possession of the records, the court said the suit cannot continue until some questions are answered. Therefore, the Justice Department cannot move forward until the appeals court provides more directions. The court added that it will schedule a conference with the parties and the Department of Health and Human Services to determine the remaining issues. The suit was filed after one nursing home, Home Instead Senior Care, refused to comply with the information provision requirements. In its brief, the Justice Department said the obligation to provide the information is not a violation of patients' rights and, therefore, the nursing homes are not justified in not releasing the records. The Department said the public benefits from having patients' records available. The appellate court agreed that the information is not a constitutionally protected privacy right and therefore not a violation of patient rights. However, the court disagreed with the federal government's argument that the nursing homes should still be allowed to resist complying with the information act because the departments of Justice, Agriculture and Labor don't have authority to enforce the act. According to the Justice Department, the nursing homes are subject to the act and the Health and Human Services Department has the authority to enforce it. The Justice Department had argued that the government could lose any obligation to investigate nursing homes that would force the department to decline to exercise its authority to stop violations. The Nursing Home Week, which runs from Sept. 22 to 28, provides information about the industry and announces events during the week leading up to the national event, which includes discussions of nursing home options and the rights of nursing home residents
